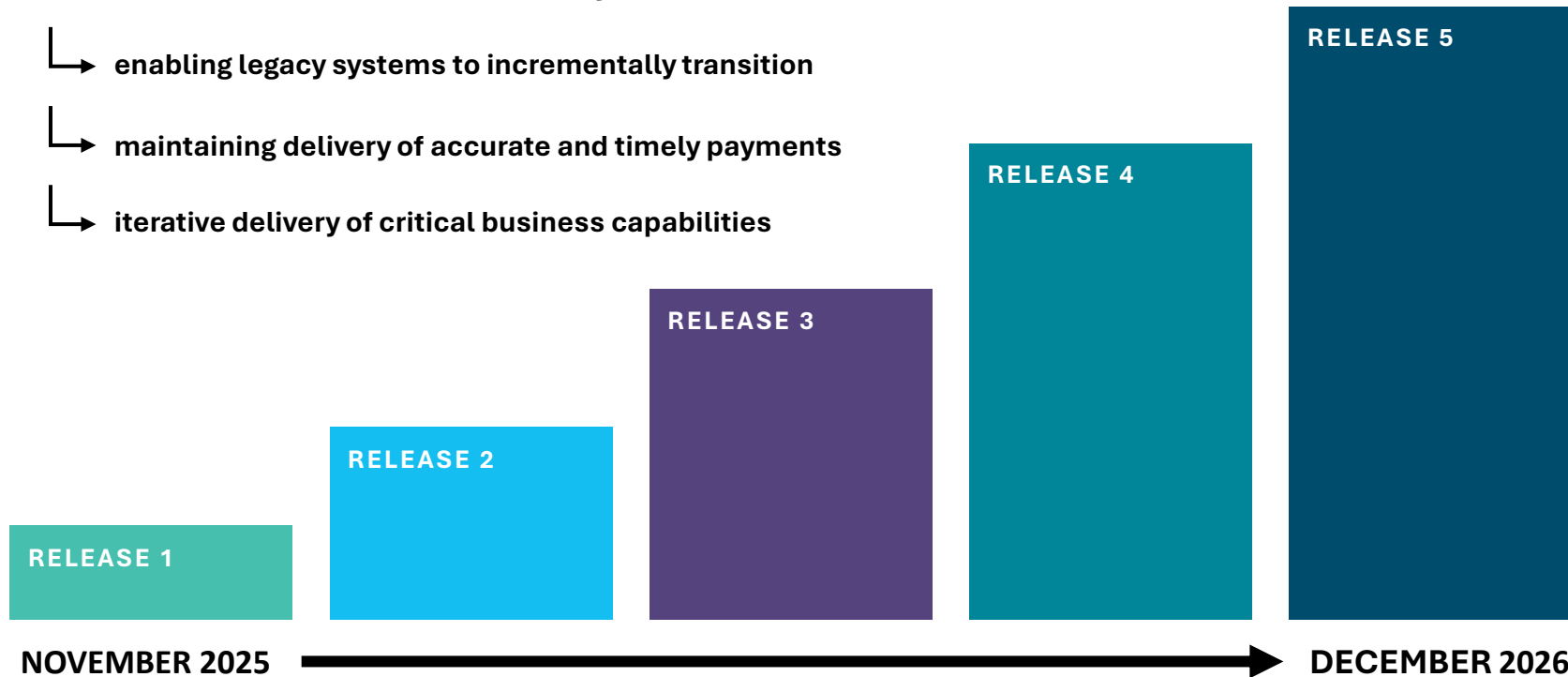
How will the EFS be delivered?

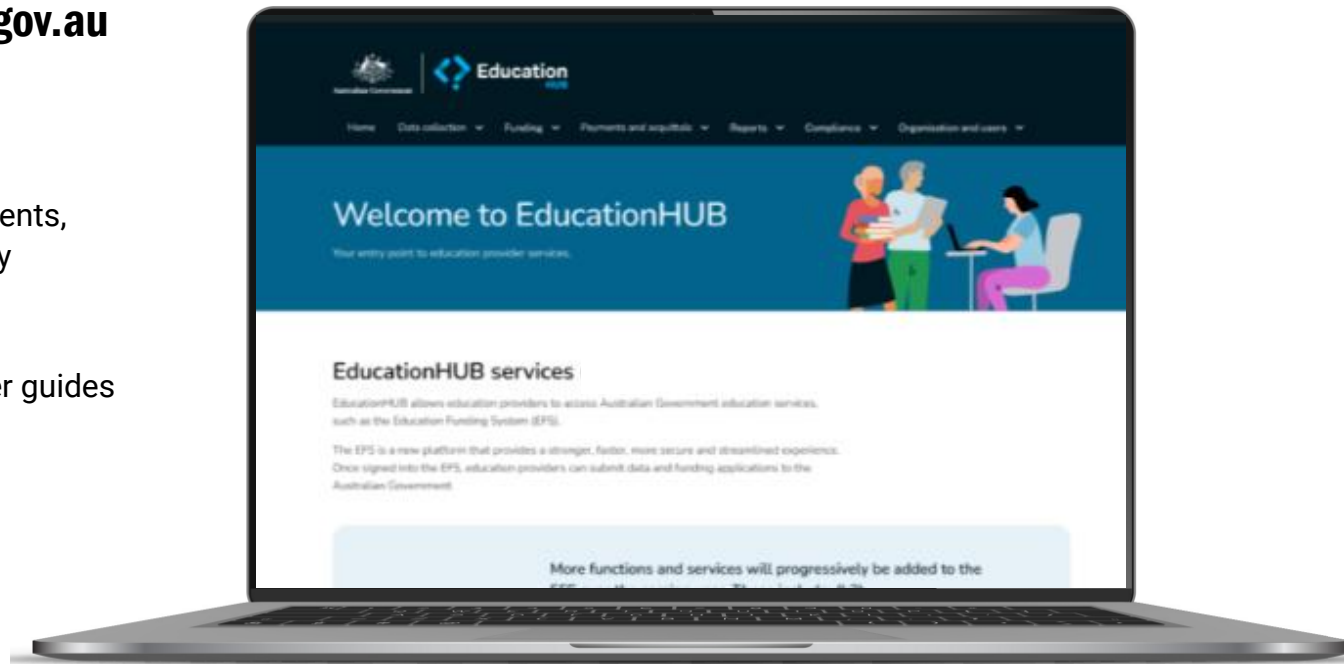

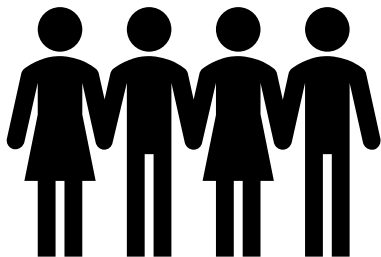

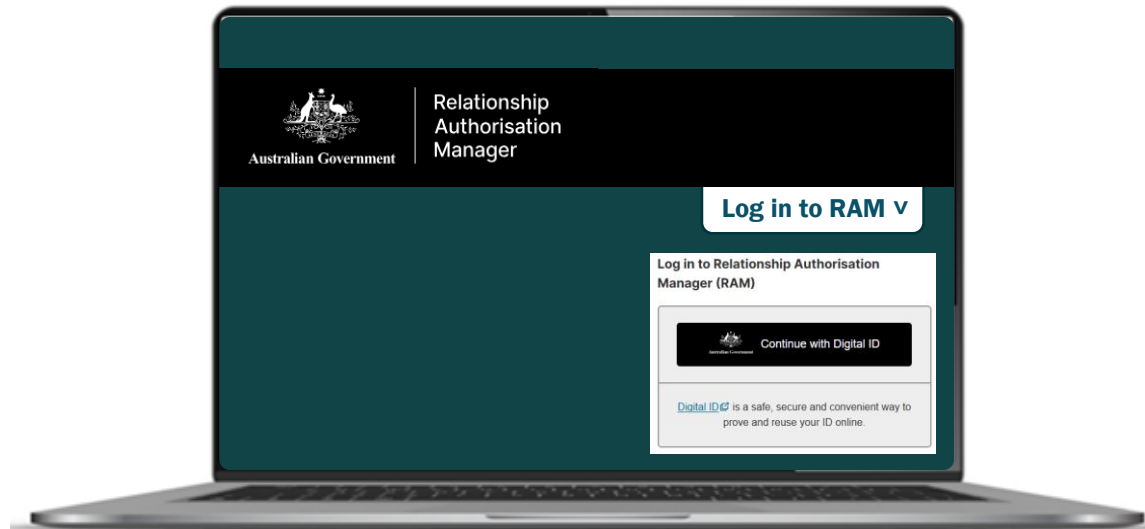
