#### The extent of the problem

Higher education as a site of gender-based violence

According to the National Student Safety Survey, 2021:

- 1 in 6 students experienced sexual harassment.
- 1 in 20 students experience sexual assault.
- 1 in 4 students in student accommodation reported sexual harassment.
- Many students found that the trauma of the original incident was compounded by their university's mishandling of their report.

1 in 3 staff in higher education experience sexual harassment National Tertiary Education Union Survey, 2023

#### The need for the National Code

Gender-based violence is an epidemic in Australia

There were 40,087 victims of sexual assault recorded in Australia in 2024, increasing by 10% (3,735 victims) from the previous year.

1 in 3 women have experienced physical violence since the age of 15

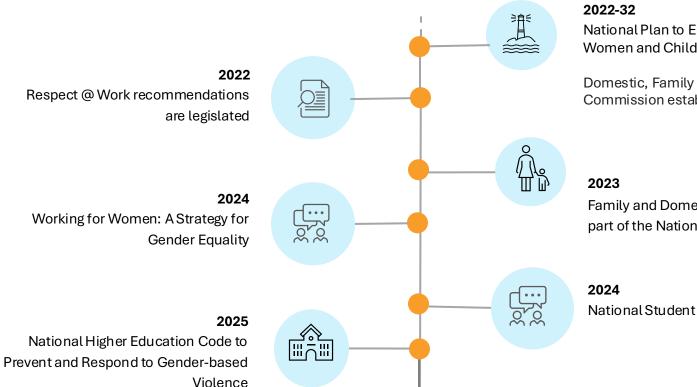
2.8 million Australians have experienced sexual violence since the age of 15

## PROPOSED NATIONAL HIGHER EDUCATION CODE TO PREVENT AND RESPOND TO GENDER.

### National Higher Education Code to Prevent and Respond to

This instrument is the National Higher Education Code to Prevent and Respond to Gender-based

The National Higher Education Code to Prevent and Respond to Gender-based Violence comprises

#### Standards of the National Code

#### Accountable Leadership and Governance

Embeds at the highest level a whole-oforg prevention & response approach to gender-based violence

#### Safe environments and systems

Requires that environments are safe and systems continuously improve.

### Knowledge and capability

Commits higher education providers to continually build knowledge and capability.

#### Safety and Support

Response and support services are safe, person-centred and trauma informed.

#### Safe Processes

All processes are safe, accessible and timely.

#### Data, Evidence and Impact

Providers use evidence to inform their approach, measure change and contribute to the national evidence base.

### Safe Student Accommodation

Requires that student accommodation is safe for all students and staff.

#### Key compliance milestones and timelines

Initial compliance date: Table A and Table B providers: 1 January 2026

Other providers: 1 January 2027

Date / Frequency	Summary of Requirements
By the <b>initial compliance date</b> (and every 4 years thereafter)	Whole-of-Organisation Prevention and Response Plan (including Gender Equality Action Plan) and Outcomes Framework endorsed by the Governing Body and submitted to the Secretary of the Department of Education.
By <b>30 June following initial compliance date</b> and every year thereafter	Annual reporting submitted to the Secretary of the Department of Education.  Names of student accommodation submitted to the Secretary of the Department of Education.
6 monthly from initial compliance date	Report against the Outcomes Framework submitted to the Provider's Governing Body.
2 years after initial compliance date and every 2 years thereafter	Report on Whole-of-Organisation Prevention and Response Plan including Gender Equality Action Plan, submitted to the Secretary of the Department of Education.

#### Standard 1: Accountable leadership and governance

- Whole-of-Organisation approach: Providers must embed gender-based violence prevention and response across all operations, policies, and practices.
- Leadership accountability: Vice-Chancellors, CEOs or equivalent must lead the development and implementation of a comprehensive Prevention and Response Plan that must include: a Gender Equality Action Plan, a Whole-of-Organisation approach, and an Outcomes Framework (reviewed every 6 months).
- Governance structures: Institutions must establish dedicated governance with expertise in student and staff safety and wellbeing.
- **Collaboration:** Plans must be informed by engagement with students, staff, accommodation providers, and those with lived experience.

#### **Embed Whole-of-organisation approach in domains of:**

- Leadership, culture and environment
- Structures, norms and practices
- Systems and infrastructure
- Services delivery curriculum, teaching and learning
- Policy and procedures
- Management and governance
- Community engagement
- Business
- Research
- Partnership

#### Standard 2: Safe environments and systems

- Safe places to learn and work: Providers must minimise risk of potential harm in recruitment and employment processes.
- GBV prevention and response policy: Providers must collaboratively develop, implement and review a whole of organisation GBV prevention and response policy, in consideration of gender impact assessments, effective response, disclosers' educational outcomes, and student and staff safety and wellbeing.
- **Prohibition of non-disclosure agreements:** Provider must prohibit the use of non-disclosure agreements, unless requested by a discloser.
- National Student Ombudsman recommendations: Provider must implement recommendations made by the National Student Ombudsman.

#### Standard 3: Knowledge and capability

- **Prevention education and training:** Providers must deliver ongoing, comprehensive prevention education and training to its students, leadership and Staff.
- Prevention communication: Providers must engage in evidence-based and evaluated prevention communications across study, work, living and social environments.
- Responding to disclosures education and training: Providers must deliver, monitor and evaluate education and training on responding to disclosures to key audiences.
- **Expertise and experience:** Providers must require that risk assessments under the National Code, formal reports, investigations and disciplinary proceedings are carried out by staff with appropriate expertise.

#### Standard 4: Safety and support

- Safe, person-centred responses: Providers must promote, assess and provide access to safe, person-centred responses, practices and support services consistent with a trauma informed approach and best practice.
- Safety and support for disclosers: Providers must consider the views of disclosers and collaboratively develop expert-led safety and support plans.
- **Support for Respondents:** Providers provide expert-developed support plans with respondents in consideration of the discloser's safety and other factors.
- **Effectiveness of support services:** Providers must monitor and evaluate its support services every three years to inform delivery.

#### **Standard 5: Safe processes**

- Accessible and anonymous reporting: Providers must provide accessible channels for formal, anonymous and third-party reporting.
- Multiple pathways to manage disclosures and outcomes of investigations: Multiple pathways ensure proportional, safe response and victim-survivor considerations.
- **Investigations:** Providers must adhere to specific requirements underscoring accountability, context, safety, discloser's views and party's rights.
- **Disciplinary processes and appeals:** Formal reports and disciplinary processes must be resolved within specified timeframes to ensure fairness and transparency.

#### Standard 6: Data, evidence & impact

Strengthening data collection systems and expanding the evidence base are essential components of a comprehensive response to addressing gender-based violence.

**Strengthened data collection systems and annual reporting:** Providers must seek and provide to the regulator, including:

- disaggregated demographic GBV data
- data for each disclosure and formal report
- data on the provider's response to disclosure
- data on the outcomes of each investigation and disciplinary process

#### **Standard 7: Safe Student Accommodation**

Safety in accommodation is not just about avoiding harm but about protecting students' rights to feel secure in their homes and to pursue their education without fear or disruption.

Applies to 3 distinct categories of student accommodation:

- Student accommodation that is directly owned, managed and/or operated by a higher education provider
- 2. Student accommodation that is otherwise under the control of a higher education provider within the meaning of 50AA of the Corporations Act 2001
- 3. Student accommodation that is affiliated with a higher education provider.

Providers are required to do everything reasonably possible to meet the National Code's standards by seeking out and reporting on legal arrangements with Affiliated Student Accommodation Providers.

#### What happens next

The National Code comes into force on 1 January 2026, and with it, providers must begin meeting their reporting obligations.

- For Table A and Table B providers the initial compliance date is January 1, 2026
- For remaining providers registered with TEQSA it is January 1, 2027

This includes publishing a Prevention and Response Plan, submitting annual data reports, and reviewing progress against an Outcomes Framework every six months.
