Standard 3 – Knowledge and Capability

Building institutional capability

- Comprehensive, trauma-informed education and training
- Tailored communication initiatives
- Staff expertise and experience for key roles
 - Responding to disclosures
 - Undertaking risk assessments
 - Undertaking investigations
 - Determining disciplinary procedures

Prevention Education and Training

Content including

- Key concepts
 - Gender-based violence
 - Gender
 - Drivers and contributing factors
 - Power dynamics
 - Respectful relationships
 - Consent
- Support services, reporting channels and resources
- Ethical bystanders
- Compassionate responses to disclosure

Prevention Education and Training

Supporting ongoing learning

- Role of evidence, frameworks, approaches and practices
- Moving beyond awareness to address drivers
- Tailoring to target audiences
- Trauma-informed
- Culturally appropriate
- Inclusive and accessible
- Ensuring safe management of disclosure

Prevention Education and Training

Collaboration and engagement

- Prevention experts
- Students
- Staff
- People with experience of gender-based violence
- People disproportionately affected
 - Women
 - First Nations people
 - Culturally and linguistically diverse communities
 - People with disability
 - People of diverse sexual orientation and gender identity

Prevention communication and initiatives

Requirements

 Evidence-informed communication across study, work, living and social environments

Planning considerations

- Objectives, target audiences and outcomes
- Tailored key messages, tested with target audiences
- Methods to reach target groups
- Activities that are:
 - Accessible
 - Inclusive
 - Responsive to disproportionately impacted groups

Responding to disclosures education and training

Requirements

- Enabling participants to apply trauma-informed and personcentred approaches
- Increasing awareness of trauma's effects
- Accounting for community needs particularly members disproportionally affected
 - Women
 - First Nations people
 - Culturally and linguistically diverse communities
 - People with disability
 - People of diverse sexual orientation and gender identity
- Safely managing arising disclosures

Monitoring and evaluation of education and training

Considerations

- Learning outcomes
- Feedback from
 - Participants
 - Prevention and response experts

Providers may be required to

- Report on how evaluation has informed future education and training
- Provide copies of evaluation reports

Expertise and experience

Required knowledge

Staff who undertake risk assessments, formal reports and investigations, and disciplinary proceedings

- Evidence based risk and protective factors
- Types, patterns and effects
- Experiences with different groups of people
- Coercive control

Additional knowledge

Staff who undertake risk assessments

- Expertise in gender-based violence risk assessment
- Competency with specific cohorts

Expertise and experience

Additional knowledge

Staff undertaking risk assessments, formal reports and investigations, and disciplinary proceedings:

- Responding effectively to people who have experienced and use gender-based violence
- Effects of trauma
- Competency in working with specific cohorts
- Procedural fairness
 - Taking and recording statements
 - Handling reports and disclosures
