# **Advisory Group Terms of Reference**

The following Terms of Reference for the Asia Education Foundation (AEF) Senior Secondary Languages Education Research Project Advisory Group (Group) have been developed to guide both Group members and AEF in ensuring that the research undertaken meets the goals and outputs specified by the Australian Government Department of Education.

### 1. Background

The Australian Government announced the 'Strengthening the Australian Curriculum' initiative in January 2014. As part of this initiative, the Government has commissioned AEF to conduct research into the provision of languages education across jurisdictions in the senior secondary years.

The research will inform all Australian governments on practical, implementable ways they can support students to continue languages study in the senior secondary years.

In conducting the research, AEF is seeking to consult with, among others, education jurisdictions, curriculum authorities and relevant professional education bodies.

# 2. Membership

Individuals or organisations have been invited to join the Group in recognition of their capacity to support languages education nationally.
